

Jersey Central Power & Light Instant Discounts Program

About the program

The Instant Discounts Program provides participating commercial kitchen equipment distributors/vendors incentives for selling qualified commercial kitchen equipment to end users or contractors serving end users. Distributors receive incentives from JCP&L, which they pass along to customers/contractors. Instant discounts are available for existing buildings only. New construction projects are not eligible. The customer must receive a minimum of 50% of the posted program incentive for eligible products.

Commercial Kitchen Equipment Instant Discount Requirements

1. Instant Discounts are provided at the distributor/vendor level
2. A customer seeking an incentive for these products must seek out an eligible distributor or contractor who works with an eligible distributor
3. Instant Discounts listed for each equipment category are the maximum instant discounts possible
