About the program

The Instant Discounts Program provides participating lighting distributors/vendors incentives for selling qualified lighting products to end users or contractors serving end users. Distributors receive incentives from JCP&L, which they pass along to customers/ contractors. Instant discounts are available for existing buildings only. New construction projects are not eligible. **The minimum customer contribution for all lighting is \$1.00**.

Process

- 1. Distributor/vendor signs up with program.
- 2. Distributor/vendor collects customer information as part of the sale.
- 3. Distributor/vendor offers instant discount on sale.
- 4. Distributor/vendor submits an application to the program for reimbursement.

Instant Discount projects \leq \$7,500 in incentives are required to go through Instant Discount program. Instant Discount projects with incentives > \$7,500 but < \$100,000 have the option to go through either the Instant Discount or Prescriptive program. Instant Discount projects with incentives > \$100,000 require pre-approval. Please consult with a participating distributor for details.
